Secretary, Treasurer Resign Emphatic Protest

A the last meeting of the executive (Monday 8th), Secretary John Marchant threw down the gauntlet of his resignation. It was picked up. A the same time, committee member Tony Ellis moved a motion successfully excluding

"Selient" representatives, including the Editor, from the meeting.

Reasons given by the Secretary for his action were outlined in an explanatory note affixed to his letter of resignation which he tabled at the close of the five-hour meeting. After the Secretary had read his

letter, Miss Gillian Hemery, 3rd year Arts student (recently elected) said: "We have tried to find out about the organisation . . . we have not re-ceived any indication as to how we have failed . . .'

Mr. Marchant then left the room. Said men's vice-president Jim Hutchison: "If he had been on the executive for a longer period last year, he might have been more tolerant."

Men's committee member Ellis then moved "That we go into committee from the time that Mr. Marchant left the room." It was proposed by others that "We go into committee from the time the letter of resignation was presented . . ." There were some ob-jections to this-Miss Hemery said: "Mr. Marchant's not here . . " but the motion was put and carried without dissension.

"Salient" staff members left the room.

Twenty-three minutes later, when the meeting came out of camera, Mr. Marchant and "Salient" representatives returned.

Chairman W. Hes then moved "That we regret Mr. Marchant's offer to resign, and that we ask him to re-consider, and that we accept his offer to remain in office for a period of two

wosks." This motion was carried with Miss Grocott recording her dissent. Asked by the Chairman if he had anything to say, Secretary Marchant replied: "That decision was not made today or yesterday, but has been accru-ing over several weeks . . . I am quite firm in my own mind about my resigna-tion. I am also very grateful that you ask me to stay in office."

The chairman declared the meeting closed, and set the next executive meeting for Monday, August 22, at 7 p.m. The following is the complete text of Mr. Marchant's letter of resignation and

accompanying statement. "I pour contempt on any person elected to Executive office who does not fulfil the obligations and functions of his appointment; I have no regard for anyone who does not attempt more than that which is his clear and simple

grounds that, without Mr. Marchant, the Executive will become another "caretaker Government" and that he can carry on his duties as well as becan carry on his duties as well as be-fore outside the Association. With this latter course "Sallent" agrees, but sug-gests that Mr. Whitta's attempt to coerce the Executive into refusing to accept Mr. Marchant's resignation, while laudable, may not achieve its pur-pose either pose either. For Mr. Whitta, it appears an easy

For Mr. Whitta, it appears an easy way out. "Salient" suggests that the wisest plan for Executive is to refuse to ac-cept either Mr. Marchant's or Mr. Whitta's resignation and, with con-sciences now brought to life, go ahead with their work of administering the funds and protecting the interests of the Association generally. Mr. Mar-chant's protest has done by this time as much as it will do, and if he can-not withdraw, the Association loses a conscientious Secretary. Mr. Whitta's resignation, as he in-

Mr. Whitta's resignation, as he in-timates, will not make much differ-

ence. Mr. Marchant's protest is directed against some who do the absolute minimum of work-even less-and who are borne along by the few whose time and energies are wholeheartedly de-voted to furthering the interests of the Association.

It is unjust for the few to have to do, on top of their own duties, the work allocated to others.

The whole sequence of events does "Salient's" view indicate most in strongly that there is something wrong with the present system of election and representation. Too often those who are elected are not capable. An overhaul of the system is necessary, but now is not the time. Finals are nearly upon us and we could not do the task justice.

The mote the basic issues become obscured, the harder it becomes to find a solution.

NEWS FLASH .-- (Rec. 5 p.m., Thursday, N.Z.U.S.N.-A.)-On Friday, August 12th, a party numbering 130 will depart from the Fort of Wellington on board the s.s. "Maori" on the first stage of a voyage of exploration into the deep South.

We are told that they are in search of the famed W.T. Shield which, although previously discovered in Wellington last August, has since gone missing and it is believed that it will be tound in the vicinity of the Octagon. Because the area is still only in a semi-civilized state, our representatives are well-armed with a varied assortment of armament ranging from miniature rines to shuttle-cocks.

Leader of the expedition is Gentle-man Jim (Sweaty) Hutchison, with Monsieur Toni Ellis a renowned swordsman and fencer-as his secondin-command. Other well-known mem-bers of the team are Messrs. Gll-berd and Stovens of long-distant running fame, Boon and Carver, whose prowess with the machet and spoon will stand them in good stead against all-comers, and represent-atives from Fiji and India, Mesars. Salt and Darrocott were members of the Wellington team which won the North Island Champs at Gisborne last month and both these players have been consistent scorers in the local competition. This combination, all NZU players last year, has shown when on form that they are the best attacking for-ward line in Wellington.

Another member of the NZU "A" team last year in E. Wright, formerly of Otago, ensures a sound defence and provides a valuable set shot when the team is faced with a tight zone defence.

Other guards include C. Hoy, a young player, who until injured a few weeks ago was improving consistently and it is hoped that he will return to form quickly when he resumes his place in the team. Both these guards have played for Wellington this season in provincial games.

P. Doogue will prove a valuable player from the "B" team being able to fill both the centre and guard positions and having gained experi-ence at the North Island "B" Grade Champs, where he represented Wellington.

Unfortunately G. McDermott and J. Hamilton (of swimming fame), two promising "B" team players were not available. It is hoped that John McPhee, a guard with plenty of ability will be able to travel with the team.

If the members of the team play up to form Victoria should again win the Title. Two factors which the team will have to note if they are going to repeat last year's win are quick service from guards to forwards in fast breaking play and the ability to move the ball in order to break a tight defence.

HARRIERS

VICTORIA has taken all the tro-phies in the Cross-Country section of Tournament for the past two years and there is no reason for doubting that it can be done again this year. The team is as follows:-Dick Gilberd, Graeme Stevens, Tony Gow, Ian Sussex, Rod Orange, John Ryan and Bob Crocker. Only two of these (Ryan and Sussex) are new to Tournament, but they have already gained sufficient experience in topgrade competition this season to allay any fears concerning their performance.

Individual performances are as follows:-

Dick Gliberd: The present NZU title-holder, Dick so far this season has been running on his natural stamina and has not yet reached the high peak of fitness that enabled him to take the title last year. However, with solid training he could repeat last years performance as the rugged Dunedin course should find him right at home.

Graeme Stevens: At the moment Gracme is running better than ever before and will also be a strong contender for the title. A brilliant final lap in the Masterton relay and a rugged third in his first assault of the 10 mile Vosseler Shield course brought him to Club Championship honours at Packakariki recently.

Tony Gow: Is another who should be well to the fore, as his time in the Vosseler was only 4 seconds slower than Stevens'. Tony is remarkably fit at present and has forced his way amongst the best in the province.

Ian Sussex: In a few months has proved a powerful and consistent runner. He put up fastest time for his lap in the Masterton Relay and rolled home in 14th place in the Vosseler, content that nobody had overtaken him during the preceding nine miles.

Rod Orange: Is having his first season in open competition and opened his account by putting up second fastest time in his lap in the Relay besides running well in the Shaw Baton.

John Ryan: Who finished about two yards behind Orange in the Club Champs has sustained his form well since. His intelligent running and his handy knack of sticking close to Sussex for much of the journey, should serve him well.

Bob Crocker: Is not yet as fit as he was for last year's run but he has the matter well in hand and will be a man to watch at Dunedin.

Victoria's prospects are bright. Everything will depend on the man who runs fourth in the team, as only the first four in count for the Dixon trophy. Whether he be Sussex, Ryan, Crocker or Orange he must finish well towards the front. And solid work by the three top men will be necessary to keep the opposition out of the major places.

Bob Calkin: (Centre-Half). An NZU player of both 1953 and 1954. Bob is the most experienced player in the team despite his youth.

He has now curbed a tendency to distribute the ball indiscriminately and directs it in a more defined and controlled manner.

Bruce Buxton: (Left-Half). Another experienced campaigner who saw the light and came to us from Auckland. He is an excellent positional half capable of stopping any right wing one way or another. Most tenacious and angles his passes well. Barry Cathro: (Half). One of the

younger members showing distinct promise and Tournament experience should do him good. (In more ways than one).

Tom Ellison: (Forward). Like Cathro a product of Taranaki and a player who is capable of a sound performance in any position. A senior player this season and good in the circle and on the plano.

Noel Civil: (Forward). Centre forward in the senior team and determined in the circle. Highest goal scorer. A Whangarei man who is prepared to forget the past and concentrate on the future.

GOVIND BHULA: (Forward). An Indian boy with clever stick work and constructive play. He is a senior Reserve player of note but no relation to either Babu or Balbir Singh. At the moment we are trying to find out however if he is connected to Community Sing.

Dave Mummery: (Forward). An ex-Palmerston North man and a solicitor to boot. Dave has represented VUC at a previous Tournament and he is a determined player who if all else fails will argue his way into a goal. Don Matheson: (Forward). Represented VUC last year and is a capable forward on all occasions. He has been a strong player in the Senior Reserve grade and should prove an asset in Dunedin. Trev de Cleene: (Forward). An ex-Canterbury player who saw the error of his ways. A senior team member whose heart is often in his mouth especially in the circle. Like the Australian marsupial Trev is fast on the hops.

Barry Boon: Well known veteran of Varsity Tournaments, Barry is known in Wellington golfing circles as a reliable and experienced player. On a handicap of 3 he may be expected to score well.

SALIENT SUPPLEMENT

12/8/55

At an emergency meeting of the Executive last night the resignation of Mr. Whitta was discussed at length but the matter was held over until 29th August. Mr. Whitta's resignation followed that of Mr. Marchant's tendered on Monday, 8th August. Subsequently, Mr. Whitta asked permission to withdraw his resignation.

As soon as the meeting was declared open <u>Kr. Rich</u> moved: 'That the Executive go into committee.' Chairman Iles refused to accept the motion at that stage. <u>Mr. Iles</u> then read Mr. Whitta's letter of resignation and his letter withdrawing that resignation, which read as follows:

'President, V.U.C.S.A.

Dear Walter,

Following our telephone conversation regarding this whole resignation affair I wish to withdraw my conditional resignation. It seems to me that John Marchant may still be made to continue in office; and that being so, I am quite prepared and willing to pull my full weight in the position of Treasurer.

Upon reflection I can see that I would be better able to inaugurate my pet, the Health Scheme, from inside the Executive, and there are a number of things I wish to push through before I leave that august body.

Finally may I say that I sincerely believe that John can be persuaded to continue in office and I shall do my part in this direction.

<u>Mr. Iles</u> then gave an account of telephone discussions between himself and Mr. Whitta prior to the meeting. <u>Mr. Whitta stated</u> that: 'Walter asked me if my resignation was definite. I replied that it was dependent on John's resignation.' This had been explained in his first letter, as the initiative that he (Marchant) had been injecting into the Executive would be gone.

Miss Fussell: 'What about the initiative that you were injecting?'

It was then moved, Lescher/Fussell: 'That the Executive do not permit Mr. Whitta to withdraw his resignation.'

Iles: 'I would prefer a positive motion.'

The motion was then withdrawn and it was moved, Hutchison/Powles: 'That Mr. Whitta be given leave to withdraw his resignation.'

Mr. Marchant had been approached by Mr. W. Iles during the day concerning Mr. Whitta's resignation. When asked to clarify his views on Mr. Whitta's resignation, Mr. Marchant said: 'If the Executive accepts Mr. Whitta's resignation I may well see my way clear to

ask the meeting to accept the withdrawal of my resignation.'

Whitta: 'This is a most interesting problem.' He went on to say that Mr. Marchant's earlier statement did not seem to point a finger at any one member of the Executive. 'My resignation therefore appears to be the easy way out for him.' Mr. Whitta had thought that his resignation would be discussed on 22nd August after Mr. Marchant's. This smacked of conniving, he said. 'It may not be so, but that is the way I am inclined to look at it. The whole purpose of my resignation was to follow Mr. Marchant's. This Executive means a lot to me. Perhaps I have suffered more than anyone else from 'Salient's' bad publicity (reference to slating of old Executive in 'Salient', July 1st, 1955.).' Mr. Whitta said that he had contacted Mr. Mason who had told him that there was nothing else that he (Whitta) could do to help him. 'I have always been willing to do whatever has been asked of me. I have one or two pet schemes that I am interested in, like the Student Health Schemo. I feel that I have shown the requisite initiative and have pulled my weight in the Executive. I could say more but I now request the Executive to allow me to withdraw my resignation.'

Iles then pointed out that some of the criticism directed against Mr. Whitta as Treasurer was unjustified. The job was a sinecure at any time.

Whitta: 'He cannot do much as Treasurer but he can as an Exec. member.'

Hemery: 'The issue is really a question of voting between two people.'

Whitta: 'That's the way he (Mr. Marchant(put it, but I hope I can still persuade John.'

Mr. Hutchison then stated that as Mr. Whitta was an N.Z.U.S.A. Delegate leaving that night he would suggest that discussion on the resignation be held over till the next meeting. He did not agree with the attitude of either the Secretary cr the Treasurer in resigning. 'It is like deserting a sinking ship' he said. The Secretary's resignation was not directed against anyone in particular but it appeared there was a certain amount of connivance, with little credit to those concerned.

<u>Powles</u>: Stated that 'We should not be driven to choose,' between Mr. Marchant and Mr. Whitta.

<u>Rich:</u> Agreed saying 'All Jim's point s are good ones. But apart from that I don't like to see the Executive say 'no' to a withdrawal of a resignation. I would rather that the matter was left for a while. John (Marchant) has given the view that either Mr. Whitta or he will have to resign.' Mr. Rich then indicated that he would support the motion that Mr. Whitta be permitted to withdraw his resignation.

<u>Grocott</u>: 'The elections were recent. Mr. Whitta was unopposed. He had already been in office a year and if he was thought to be unsatisfactory, why was an opponent not found.

Mr. Iles then explained that the Treasurership was the only position which requires a qualification (only a qualified accountant could have stood against Mr. Whitta).

Fussell (to Whitta): 'What would you do if we accept Mr. Marchant's resignation?'

Whitta: 'I cannot say. I feel that I can still persuade Mr. Marchant to withdraw his resignation.'

Barnett: 'Mr. Whitta has made clear to us his position. I would now like to hear Mr. Marchant clear up his own position.'

<u>Mr. Marchant</u> then read a statement: 'Ladics & Gentlemen, By the severity of my action we have suddenly become the centre of critical interest. To many my determination to resign has been misunderstood and in some cases sadly misconstrued.

My purpose has been to shock you into the realization of the remarkable responsibility which Executive office imposes. If you are sensitive you will have been terrified, as I have been, by the magnitude of your task. Where thirteen people are required to minister to the needs of the many College clubs and societies there is no room for anyone who does not throw himself wholeheartedly into his work. Those of our number who have worked hard and conscientiously within the limited time which is available to them will be clear and settled in their consciences; those of us who have been tardy will be spurred into action if we are worthy and those who lack real interest will consider their resignation.

I promise further outbursts if some who have been tardy do not reveal a new spirit of real enthusiasm and work, '

Grocott: 'Mr. Marchant's action is irresponsible.'

<u>Iles</u>: denied that there had been any connivance: the meeting had been called on his own authority to consider Mr. Whitta's resignation and to clarify the position. In view of the fact that Mr. Marchant's resignation statement was in general terms, he felt that the sooner the position was clarified the better. He was quite sure that it was not possible to withdraw a resignation without the permission of the body to which it was addressed. 'I do not feel that the resignation should be withdrawn, nor do I feel that it should be accepted at this stage. I suggest that the resignation lie on the table until the meeting of 22nd August.'

Whitta: 'I can see the purpose behind this, but I would like to go south on the understanding that the withdrawal of my resignation has been accepted. I feel strongly about this attempt to condemn one member of the Executive.'

Ellis: 'Would you resign again if Mr. Marchant does not withdraw his resignation.'

Whitta: 'I will not want to resign again if Marchant resigns. The position has changed considerably since Monday night.'

<u>Rich:</u> 'It seems that the people here must decide whether they want Mr. Marchant on the Exec. or Mr. Whitta. This is not the time to decide it.

Hemery: 'Why does Mr. Whitta think that Mr. Marchant will reconsider his decision within two weeks when he has been considering it already for a period of some weeks?'

Whitta: 'Because of the new circumstances which have arisen.'

<u>Marchant</u>: 'I have not tried to remove you. I still hold to my first statement. I would have achieved my purpose if anyone who had a twinge of conscience resigned. I promise further outbursts if some who have been tardy do not reveal a new spirit of real enthusiasm and work.'

Hutchison: 'What would have been the position if you had been elected President? Would you still have resigned?'

Marchant: 'Most certainly.'

Hemery: 'Do you hope to get somebody better and go against the whole idea of a voting system? If everybody in the world were not given a second chance a lot of good work would not have been done."

Marchant: 'I would be prepared to give a second chance.

Grocott: "Thank you very much."

<u>Fussell</u>: Then said that she felt that Mr. Marchant was underestimating the authority of his position. If, instead of resigning, he had gone to the people to whom he was referring and had spoken to them individually, it would have carried a lot of weight. Much more perhaps than he thought.

Barnett: 'If Mr. Marchant resigns whenever things get slack he is setting himself up as a subjective judge.'

Marchant: 'I am entitled to do this. 2,000 others are doing this.'

<u>ElHs</u>: 'People should be able to do whatever they like as long as they don't hurt others.'

Whitta: 'Because I am going south tonight and a taxi is leaving shortly, I would like the motion to be put.'

Hutchison: 'Can I withdraw my motion.'

Iles: 'Only with the consent of your seconder and the leave of the meeting.

Powles: 'I don't want to see us make a hasty decision. I withdraw my seconding.'

With the leave of the meeting the motion was withdrawn. It was then decided on the motion Hutchison/Lescher: 'That the resignations of Mr. Marchant and Mr. Whitta lie on the table until 29th August!(all members of Executive could not be present at the next scheduled meeting on 22nd August and Mr. Marchant agreed to remain in office until 29th August.)
